Material harm includes actual or potential harm to the health or safety of human beings or to ecosystems, that is not trivial or that results in actual potential loss or property damage of an amount over \$10,000.

Procedure for communicating with neighbours and the local community

Castlereagh Waste Management Centre (WMC) is a closed landfill undergoing rehabilitation works that include acceptance of VENM (clean fill) for re contouring and planting of trees.

Waste Assets Management Corporation (WAMC) offers the Community Advisory Committee (CAC) as a venue/forum to learn about operations on site and to have any questions or concerns addressed. There is an open invitation for residents/neighbours to attend the CAC, details of which can be found on this website.

Emergency Response Plan

Castlereagh WMC has an Emergency Response Plan which is activated when an incident occurs. The Emergency Response Plan, after identification of the potential for emergencies at the site, contains measures that prevent and mitigate potential safety and environmental impacts.

- The majority of potential pollutants on site are:
 - > Fuels, oils and cleaners associated with the maintenance and servicing of machinery:
- Appropriate quantities for regular use are stored as per recommendations (bunds, secure compounds etc.)
- ❖ The site-specific emergency response procedures include:
 - Chemical spill
 - On-site fire
 - > Explosions (landfill gas infrastructure) Vehicle liquid spill
 - External emergencies (flood, earthquake, storm etc)

Neighbours

The Emergency Response Plan procedures will, at the time of the incident, or, if there is a likely impact, require communication with some or all the following neighbours:

- Caretaker &
- Francis Greenway Correctional Centre.

Local Community

Should an incident occur which is likely to impact on the local community in Berkshire Park, WAMC will call the residents that have left contact details with the CAC, post information on the website and/or ask assistance from emergency services as required.
